Some college students even think they have the ability to protect their own safety and interests from infringement. Colleges and universities should actively play the role of network publicity platform, through strengthening the publicity and education of college students' safety laws and regulations, campus security management system and analysis of various typical cases to enhance the awareness and ability of college students' safety prevention.

(3) The surrounding environment of the campus is complex. With the expansion of college enrollment and the popularization and application of "Internet plus", the composition of student groups has become increasingly complex and diverse, and the surrounding environment of colleges and universities has become increasingly complex. In the surrounding area of the campus, there are some illegal elements, illegal vendors, and bad information providers engaged in illegal activities on the campus. Some illegal elements are motivated by their desire to use media such as the internet to defraud students online. Schools should strengthen education on college students' awareness of network security, publish information or links to prevent fraud and robbery on campus websites, post bars, microblogs, and other platforms, and conduct necessary supervision on illegal vendors outside the school.

(4) Lack of campus mental health education. The psychological problems of college students are increasingly prominent and complex. Most colleges and universities generally lack the degree of attention to and investment in college students' mental health education, some colleges and universities mental health education courses and psychological counseling services are separated or only as an elective course. Some colleges and universities have not established special psychological counseling institutions or full-time teachers; Some colleges don't offer psychology courses specifically for students; Some universities have not yet established students' psychological files. College students have confusion and pressure in academic, emotional, employment and other aspects. It is difficult to deal with and deal with some emergencies correctly, and even produce symptoms such as depression and anxiety. These problems need help and guidance from the school and relevant departments.

(5) The security forces on campus are weak. With the development and progress of social economy, security issues are no longer limited to public security issues and criminal cases, and some issues affecting the personal safety of teachers and students have also begun to attract attention. In campus security, the construction of security teams in colleges and universities is relatively weak, unable to adapt to the increasingly complex campus security management situation as a whole, and also does not match the needs of students for safety education. The lack of security forces on campus restricts the development of security work, which is prone to safety accidents, conflicts and disputes.

### **3. Countermeasures and Suggestions for Improving the Campus Security Management System**

In recent years, campus security situation is becoming more and more serious. As the important participants of campus security, college students' safety consciousness and safety ability directly relate to teaching, management and service results. ### ***3.6 Construct and improve the construction of college campus security facilities***

Third, increase capital investment.
