Therefore, as a kind of "hidden" music, the voice over has a strong sense of subjectivity through the story, deeply affecting the audience's emotions and giving the audience a direct feeling. When it comes to voice in, there are two scenes in the nightclub. The first scene shows the work environment of Liu Sihui. Every day, she earns money from a pole dance at a nightclub to buy a sky high price medicine for her daughter with chronic myeloid leukemia. The second scene shows Cheng Yong's team celebrated together, showing that they were earning money through the channels of importing drugs.

1.3 The Application of Synchronization of Sound and Picture, Contrast of Sound and Picture, and Parallel Sound and Picture

First of all, the synchronization of sound and picture refers to the unity of the artistic style, the background and the social environment of music and picture content, and is followed by the unity of the mood and atmosphere of music and pictures.
