For instance, Zhejiang Province explicitly acknowledges the seawater quality issues in the Yangtze River estuary region within its marine sports development plan. The subpar seawater quality renders Zhejiang's nearshore areas unsuitable for activities like yachting, sailing, windsurfing, surfing, and diving. Furthermore, the scarcity of high-quality beach resources also hinders the development of coastal sports and leisure activities in the province

3.2 National character and cultural factors

China is a multi-ethnic country, where different ethnic groups have their unique cultural traditions and lifestyles. These factors to some extent influence the promotion and participation in coastal sports and leisure activities.
