2.2. Lack of Systematic and Comprehensive Understanding of Curriculum Ideological and Political Teaching

Under the influence of this teaching inertia, the majority of professional course teachers also lack corresponding ideological and political concepts, which makes the ideological and political education of professional courses in an embarrassing situation. 2.3. Lack of In-depth Excavation and Innovative Integration of Ideological and Political Resources Contained in Professional Course

At present, the classroom teaching of organic chemistry mostly uses scripted lectures to carry out ideological and political education, which affects greatly the effect of ideological and political education. The ideological and political education in the classroom should be connected closely with the thoughts, study and life of college students in order to resonate with the students. Some students only pay attention to the learning of professional knowledge, but ignore the shaping of their own ideological quality. 3. Exploration and Practice of Improving the Quality of Ideological and Political Teaching of Organic Chemistry

Through the previous analysis of the current situation, we found that the low quality of ideological and political teaching of organic chemistry is mainly caused by the lack of professional teachers, the lack of systematic and comprehensive understanding of the ideological and political teaching of the professional course, and the lack of in-depth understanding of the ideological and political resources contained in the professional course. For the above problems, we explore the corresponding solutions and can take the following measures:

3.1. Cooperate with Ideological and Political Teachers to Strengthen the Cultivation of Ideological and Political Teaching Ability of Teachers' Courses

In response to the lack of professional teachers, organic chemistry teachers in colleges and universities can actively cooperate with ideological and political teachers to cultivate students' good professional quality and skills. Organic chemistry teachers should encourage students to combine the knowledge they have learned in the classroom with practical applications, to popularize chemical safety knowledge for community residents, and to organize health education activities. In this activity, students will feel their value to the society and cultivate their interest in their majors [3].

3.2. Systematic and Comprehensive Formulation of Ideological and Political Teaching Objectives and Syllabus for Organic Chemistry Courses

Reasonable teaching goals are a prerequisite for realizing education and teaching. In the teaching of "course ideology and politics", the first thing to do is to clarify the teaching goals of course ideological

According to the syllabus of the course, combined with the professional knowledge points of the chapters, the ideological and political connotations are excavated and integrated into a specific ideological and political case database for organic chemistry courses. The organic chemistry "course ideology and politics" case library can be established based on the development history of organic chemistry: First, we can excavate the stories of scientists in the development history of organic chemistry, from which we can understand the quality of scientists; second, we can present the twists and turns in the development of organic chemistry and from which we can understand the indomitable scientific spirit; third, we can highlight the key role our country played in the history of organic chemistry, and from which we can cultivate the patriotism of college students [4]. These case bases can be transplanted and used in actual teaching, realizing the seamless connection and natural transition of professional knowledge and ideological and political resources, and also conducive to the reference and promotion of other courses.

4. Conclusions

The college period is a critical period for the formation of students' world outlook, outlook on life and values. It is one of the important tasks facing colleges and universities to improve the ideological and political literacy of college students through ideological and political courses and to cultivate new talents of the times. Organic chemistry is a very important professional basic course for science and engineering students in colleges and universities. Therefore, it is very necessary to carry out ideological and political education in organic chemistry courses.
