Solutions to the Problems Existing in the Teaching of Classical Singing

Let us just imagine that if a student is selfish and depressed, he will not be able to express the beautiful emotions and noble sentiments of classical singing songs. At the same time, students should also have ideological qualities such as perseverance, hard work, and persistence, because in the process of learning classical singing, they will encounter a series of difficulties and setbacks. Only with the above good qualities can they have the courage and continuous flow to overcome these difficulties motivation. In the long river of history, it is not difficult to find that any famous classical singer has these good morals and qualities before he climbed to the peak of art. Therefore, students who study classical singing should constantly improve their moral character. Only by enriching and perfecting ourselves can we go further in this field.

Secondly, students who study classical singing must have a certain degree of music quality. In the usual classical singing training, we should pay attention to improving students' music quality, which plays an important role in improving the effect of classical singing, [8], such as rhythm, intonation, musicality, etc. Rhythm is an important element of music. It is the way of expressing the external image and emotion of a work. If the rhythm is different, the musical image and expressive force of the work will also be different. People with a strong sense of rhythm can devote themselves wholeheartedly to the work, allowing their emotions and body rhythm and rhythm to blend together, thereby accurately expressing the thoughts and feelings of the song.

In addition, students will be more or less affected by emotions in the process of learning classical singing. When the mood is abnormal, the timbre and sound quality of the students' singing will decline. Therefore, for those bad emotions such as sadness and anger caused by external things or the environment, students should have good self-control ability and learn to regulate their own emotions. Finally, students should have a good overall cultural mastery and a correct aesthetic. Classical singing is not only an artistic discipline, but it also has a close relationship with other comprehensive disciplines.
