Third, implement the strategy of strengthening the team with talents, vigorously advocate "professionals do professional work", actively train "experts" and "craftsmen" fire law enforcement personnel through large-scale training and large-scale competitions, regularly arrange young comrades to attend classes with old comrades, and train grass-roots comrades and government comrades in rotation, send existing law enforcement personnel to local universities for professional training, strengthen communication and contact with fire protection mechanisms in some developed countries, and strive to cultivate a growing cultural soil, build a scientific and practical growth platform and establish study.

#### 4. Innovation of fire control publicity and education methods.

With the development of Internet and new media technology, people's ways to obtain and disseminate information have changed from traditional media to relying on the Internet, Weibo, WeChat, smart phones and other emerging networks and mobile media. In this era, to carry out fire protection propaganda work, it is necessary to firmly grasp the outstanding characteristics of new media communication methods, adopt modern output methods, mobilize various new media platforms to serve the main purpose of the work, and cooperate with traditional media propaganda, so as to create a strong fire protection propaganda atmosphere in all directions, and improve propaganda efficiency and publicity effect. For example, fire protection propaganda departments can use WeChat in WeChat official account and Weibo, etc. Publish some publicity and education posters, pictures and texts of fire laws and regulations, short videos of fire protection knowledge, daily law enforcement inspections or some practical cases to people at any time, so that people can master more common knowledge of fire safety, and at the same time, communicate and interact with the public online, answer questions for them, and highlight the diversity of publicity forms. Secondly, it is also possible to spread fire protection knowledge through LED screens and communicate with the public, so as to create a good publicity environment for fire protection science in society.

## 5. Promotion of the construction of fire Internet of Things.

As an advanced concept of urban safe operation and management, the Internet of Things is the practical application and concrete embodiment of the latest concept and technology of the Internet of Things in the field of fire protection. ## 6. Dependence on the professional strength of the third party.

Fire supervision and inspection is the main responsibility and obligation of the fire department. After the investigation of previous fires, it is found that the fire supervision and inspection is not in place, which will bring great hidden dangers to safety and is one of the causes of fires. At present, the requirements and standards for fire supervision and inspection work are getting higher and higher. Some units have a large area under their jurisdiction and involve a wide range of business forms. In addition, there are many transactional work and the level of fire law enforcement personnel is uneven, which makes it difficult to meet the needs of daily supervision and inspection. Actively communicate with relevant departments and units, establish a fire safety expert database, and provide fire safety
